

General Terms of Agreement

General

The following terms and conditions set out the legal rules applicable to the “Internationale Energiewirtschaftstagung 2025” (IEWT 2025) in Vienna from 26th to 28th of February 2025 and related events. Participants shall be bound by these terms and conditions upon registering for the Conference and are advised to read and understand these terms carefully before registering. The Organizer will not accept any conditions contradictory to or deviant from these general terms and conditions.

Organizer

Responsible for the organization of the Conference is the Technische Universität Wien, Institute of Energy Systems and Electrical Drives – Energy Economics Group, c/o Gusshausstrasse 25-29/370-3, 1040 Vienna, Austria (UID: ATU37675002).

Registration

Registration to the Conference must be done through the online registration system on the Conference Website prior to arrival at the Conference venue. Registrations will be handled on a first come, first served basis due to limited capacities. Participants will receive an automatic confirmation of the registration details by email. If you do not obtain anything, please send an email to iewt2025@tuwien.ac.at or frey@eeg.tuwien.ac.at to make sure that your booking was successful. The registration is only valid after receipt of the registration fee. Please notify any modifications to your registration immediately.

Fees and Payment Conditions

The registration fees are announced at the Conference Website and include admission to all conference sessions, detailed program, morning and afternoon refreshment breaks, lunch and social dinner as announced at the Conference Website.

Travel, accommodation and additional meal expenses are excluded from registration fees and result in additional expenses. All payments are made in Euro.

Cancellation

Cancellations are allowed if requests are received on or before December 31st, 2024. If requests are received after December 31st, 2024, a non-refundable administrative fee of € 100 applies.

Cancellations made after January 31st, 2025, as well as 'no shows', are liable for the full registration fee. The Participant has the right to appoint a substitute at any time without additional cost until February 10th, 2025. All cancellations and changes must be submitted in written form or via email – with indication of full name, invoice number and bank details for reimbursement – to:

Disputes
